- LEVEL A** First Time Rider, Has never ridden before
- LEVEL B** Basic Rider, Can do pendulum and some turns on easy Green runs.
- LEVEL C** Novice Rider, Can do basic linked turns on Green runs
- LEVEL D** Intermediate Rider, Can confidently link turns on Blue runs.
- LEVEL E** Advanced Rider, Can ride easily on Blue runs and is confident on the steeper terrain.
- LEVEL F** Expert Rider, Rides all terrain and enjoys the park & pipe.
