
The details of the Introductory Membership Program are as follows:

- A \$1,000 deposit (including taxes) with your application reserves a place for you and your family in this program for the 2010/2011 season.
- Once your application has been processed, you will be invoiced \$2,500 as dues for your family, regardless of the size of your family which entitles your family to ski for the entire season.
- If you join as a Full Voting Member prior to April 30, 2011, the \$1,000 deposit will be applied towards your initiation fee (current initiation fee is \$37,500).
- In addition, if you join prior to April 30, 2011, you will be eligible for an exemption from the Capital Improvement Levy for the first year of your membership.
- You will also be entitled to a \$500 credit towards ski and snowboard programs in the first year of your Full Voting Membership.

We are proud of Alpine Ski Club and on behalf of the Board of Directors and general membership, we invite you to join us for the 2010/2011 ski season.
